## SECTION I: INSTRUCTIONS TO BIDDERS

#### 1. Rights of Public Entity

The **Office of the Prime Minister** reserves the right:

- (a) To split the contract as per the lowest evaluated cost per item, or
- (b) To accept or reject any quotation; and
- I to cancel the quotation process and reject all quotations at any time prior to contract award.

#### 2. Preparation of Quotations

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

A record of the Quotation **Opening stating the name of the bidders, the amount quoted, the presence or absence of mandatory requirement/ written undertaking and Bid Securing Declaration,** will be posted on the website of the OPM and available to any bidder on request within three working days of the Opening.
