SECTION I: INSTRUCTIONS TO BIDDERS

1. Rights of Public Entity

The Ministry of Justice and Labour Relations reserves the right:

2. Preparation of Quotations

3. Validity of Quotations

Quotations should be sealed in a single envelope, clearly marked with the Procurement Reference Number, addressed to the Public Entity with the Bidder's name and contact information at the back of the envelope.

8. Submission of Quotations

Quotations should be deposited in the Bid Box located at The Ministry of Justice and Labour Relations, *Tallas* Building, Independence Avenue, Windhoek not later than 22 August 2025 by 12h30. Quotations by post or hand delivered must reach Ministry of Justice and Labour Relations, Ground Floor in the Bid box next to the Security Office by the same date and time at latest. Late quotations will be rejected.

Quotations received by e-mail/fax will not be considered.

9. Opening of Quotations

Quotations will be opened internally by the Public Entity immediately after the closing time referred to in ITB 4 above. The bid opening report with the quoted amounts would be available to any bidder on request within seven (7) working days after the opening.

10 Evaluation of Quotations

The Public Entity shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of evaluated cost to determine the lowest evaluated quotation.

11. Technical Compliance

Bidders shall submit along with their quotations documents, catalogues and any other literature to substantiate compliance with the required specifications and to qualify deviations if any with respect to Public Entity's requirements.

The Specifications, Performance Requirements and Compliance Sheet details the minimum specifications of the goods/items to be supplied. The specifications have to be met but no credit will be given for exceeding the specifications.
