## REPEAL OF OBSOLETE LAWS ACT, 2022

**ACT**

**To provide for the repeal of certain obsolete laws; and to provide for incidental matters.**

*(Signed by the President on 29 December 2022)*

**BE IT ENACTED** as passed by the Parliament, and assented to by the President, of the Republic of Namibia as follows:

**Repeal and amendment of laws**

1. The laws specified in Column 2 of the Schedule are repealed or amended to the extent set out in Column 3 of that Schedule.

**Short title and commencement**

2. This Act is called the Repeal of Obsolete Laws Act, 2022 and comes into operation on the date determined by the Minister by notice in the *Gazette*.
