1. Rights of Public Entity

The *Ministry of Justice* reserves the right to:

- a) To split the contract as per the lowest evaluated cost item where applicable
- b) To accept or reject any quotation;

- d) Reduce or increase the quantity of items where applicable;

2. Preparation of Quotations

6. Works Completion Period

8. Submission of Quotations

9. Opening of Quotations

Quotations will be opened internally by the Public Entity immediately after the closing time referred to in section 8 above. The Bid Opening report with the quoted amount will be available to any bidding on request within seven (7) working day after

the opening, will be posted on the website of the Public Entity and available to any bidder on request within seven (7) working after the opening.

10. Evaluation of Quotations

The Public Entity shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of evaluated cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation.
